



PRIVACY POLICY

About Our Privacy Policy

At The Savings Bank Life Insurance Company (“SBLI”), we want you to know that we take every measure possible to maintain confidentiality of your nonpublic personal financial information (“Information”). The collection, use and disclosure of this Information is regulated by law. Accordingly, we provide this notice to describe our current Privacy Policy and our approach to protection of this Information in accordance with applicable law. During the continuance of your relationship with SBLI, we will send you our current Privacy Policy at least once annually, as required by law.

How We Gather Information

SBLI collects and uses nonpublic personal information from you in order to provide, administer and service financial products and services, including insurance and annuities. The type of information we may collect includes information, such as name, address, telephone number and we may also collect other information such as your health, financial and employment history. While we collect most of this information from you during the application or claim process, we may also collect information from other sources, such as medical professionals and consumer reporting agencies. We also have personal information about your transactions with us, such as information about your insurance policy, premiums and claims.

Confidentiality of Medical Information

We may collect medical information to provide you with a product or to pay a claim. We know that you are concerned with the privacy of your medical information. We want to assure you that we do not use, sell, or share it for any purpose other than to assess your application for coverage with us, to administer to your policy or claim, or as otherwise permitted or required by law.

Disclosure of Information to Nonaffiliated Third Parties

Your nonpublic personal information is regarded by SBLI as confidential information. Unless required or permitted by law, SBLI does not disclose your Information to nonaffiliated third parties. During our normal course of business, and as permitted by law, we may disclose Information collected about you to nonaffiliated third parties. These disclosures may be made to companies who provide services for us such as, providing you with an insurance quote, processing, servicing, and administering your insurance policy or claims. Whenever we use other nonaffiliated third parties we expect them to maintain the confidentiality of your Information and abide by all applicable privacy laws. These third parties are not authorized to use or disclose any other information they are provided without the written consent of SBLI.

Our Former Customers

Even if you are no longer an SBLI customer, this Privacy Policy will continue to apply to you.

Our Security Policies and Procedures

The only persons authorized to have access to your Information are persons who need to know the Information to provide products and/or services to you or to SBLI or to perform functions for SBLI. This is limited to employees and representatives of SBLI and nonaffiliated third parties to whom the Information is disclosed in accordance with applicable law.

SBLI maintains physical, electronic and procedural safeguards that comply with our security policy and applicable law to protect the confidentiality of your Information.
